A Forensic Psychiatrist's Guide to Understanding Psychological Assessment

- 3. Evaluate a third party psychological assessment, including signs that a psychologist is needed for further evaluation.

Dr. Angela Carter, Ph.D., C.Psych.

Dr. Angela Carter is a registered psychologist practicing in the areas of Clinical Psychology, Forensic Psychology, and Neuropsychology, with both adults and older adults. She completed her doctorate at Queen's University, and she has trained and/or worked at a variety of institutions including the Centre for Addiction and Mental Health, the Royal Ottawa Hospital, the Mental Health Centre Penetanguishene (formerly Oak Ridge), Providence Continuing Care Centre, and Toronto Rehab. In 2009, she moved into full-time private practice, and most of her current forensic work is in the civil context. She conducts independent psychological and neuropsychological evaluations, assesses claims of trauma for civil litigation, conducts workplace violence risk assessments, and assesses fitness to practice uses (including nurses for the College of Nurses of Ontario, and physicians for the College of Physicians and Surgeons of Ontario and the Physician Health Program). She still occasionally conducts assessments for criminal Court as well; these assessments have addressed issues relating to Criminal Responsibility, Fitness to Stand Trial, and Dangerous Offender applications. She has been qualified in Superior Court as an expert witness in the areas of Forensic Neuropsychology and also in Malingering, and has been qualified as an expert witness in Neuropsychology by the College of Physicians and Surgeons' Board of Inquiry. Finally, she regularly serves as an Oral Examination Chair for the College of Psychologists of Ontario, and has served as an expert consultant for the College of Psychologists' Inquiries Complaints and Reports Committee.

Dr. Percy Wright, Ph.D., C.Psych.

Dr. Wright is a Psychologist in forensic practice. He has been involved in assessment of Forensic patients at CAMH, Oak Ridge (now Waypoint Centre) and in private practice. He has published articles involving the use of various tests with forensic groups including neuropsychological and intellectual measures as well as personality measures including the MCMI, MMPI and HCR. He has also been involved in training PHD level Psychologist candidates and psychiatrists pursuing their forensic designation.

He has served for many years as a member of the Specialty Committee in Psychiatry for the Royal College of Physicians and Surgeons of Canada. He has completed the microprogram and the DESS in Insurance and Medicolegal Medicine at University of Montreal. He has s CPD Certificate in Medical Law and Ethics from the University of Edinburgh. He is a Certified Forensic Psychiatrist in private practice at the Medico-Legal Institute of Quebec. He is particularly interested by issues related to civil litigation.
