### Research, Issues, and Approaches in Forensic Risk Assessment with Indigenous Clients

### **Learning Objectives:**

At the end of the presentation, the participants will be able to:

- 1. Describe the assessment issues and clinical, legal, and sociohistorical context and controversies around forensic risk assessment with indigenous persons.
- Identify the risk assessment tools and related forensic assessment measures with the best predictive properties and evidence of least ethnoracial bias for use with Indigenous persons.
- 3. Identify and evaluate potential culturally specific factors, strengths, and resiliencies that have relevance for forensic risk assessment with Indigenous persons.
- 4. List evidence drive conclusions and practices for selection and application of risk tools for use with Indigenous correctional and forensic clients.
- 5. Identify strategies for integrating risk and other clinical assessment information into risk formulations and assessment recommendations and conclusions with Indigenous persons.

### **Description:**

Indigenous peoples are overrepresented in correctional systems internationally, reflecting a history of systemic racism and colonial oppression, and the practice of risk assessment with this population has been a focus of legal and sociopolitical controversy.

This 3-hour pre-conference seminar will focus on empirical research developments, clinical and legal issues, and evidence and culturally informed approaches in forensic risk assessment with Indigenous persons. We begin with an overview of the background and the clinical, legal, and sociohistorical context and controversies of forensic risk assessment with Indigenous persons. We proceed to review research developments and findings pertaining to risk instrument predictive properties, risk/need factors, and culturally relevant factors with Indigenous clients, followed by conclusions on the current risk assessment with this population. We follow with a discussion and review of clinical applications and related applied directions for risk assessment with indigenous persons, specifically, regarding interviewing and instrument administration, utilization of risk assessment information, evaluation and incorporation of strengths and culturally specific factors into risk assessments, and developing and languaging assessment report recommendations and conclusions.

In this approach, we lean heavily on the risk-need-responsivity (RNR) model of correctional assessment and intervention within a culturally (and general diversity) responsive framework of forensic service delivery.

### Bio – Mark Olver, Ph.D., R.D. Psych.

Dr. Mark Olver Ph.D. is Professor and Registered Doctoral Psychologist in the Clinical Psychology Program at the University of Saskatchewan, Canada, where he is involved in graduate and undergraduate research supervision, teaching, administration, clinical training, and applied forensic research. Prior to his academic appointment, Mark worked as a clinical psychologist in various capacities, including providing assessment, treatment, and consultation services for justice involved youth in the Saskatoon Health Region and for federally sentenced men in the Correctional Service of Canada. He has published over 185 journal articles and book chapters and his research interests include risk assessment and correctional treatment, justice involved youth, psychopathy, variations in human sexuality, and the evaluation of therapeutic change. He is the co-developer of the Violence Risk Scale-Sexual Offense version (VRS-SO) and the Violence Risk Scale-Youth Sexual Offense version (VRS-YSO) and he provides training and consultation services internationally in the assessment and treatment of high psychopathy, sexual, and violent offending populations.

### Bio – Keira C. Stockdale, Ph.D., R.D. Psych.

Keira C. Stockdale has a Ph.D. in Clinical Psychology and is a Registered Doctoral Psychologist. Her clinical experiences have included the provision of assessment and treatment services to high-risk, justice-involved adult and youth in both institutional and community settings. Keira was previously employed at the Saskatoon Police Service with a mandate to provide clinical and behavioral science knowledge/expertise to the design, implementation, and evaluation of police and integrated community safety practices. Keira has recently transitioned to a new role as Associate Professor in the Clinical Psychology Program in the Department of Psychology and Health Studies at the University of Saskatchewan. In this capacity, she is currently working on applied community safety research initiatives with university, government, and police partners and supervises psychology graduate students, residents, and postdoctoral fellows in clinical and research activities.

- **2.** Identify the health and economic consequences of FASD (Why should Forensic Psychiatrists concern themselves with FASD?).
- 3. Assess and Manage FASD.
- 4. Describe the neuropsychological profiles of justice-involved individuals with FASD.
- **5.** Apply skills in the assessment of criminal responsibility and fitness to stand trial in people with FASD.
- 6. Appreciate the significance of ADHD comorbidity in individuals with FASD.

### **Description:**

Fetal Alcohol Spectrum Disorder (FASD) is a critical yet often under-recognized condition in forensic psychiatry. This session aims to enhance participants' knowledge and skills regarding the identification, assessment, and management of FASD in clinical and forensic settings. Attendees will be equipped to recognize the clinical indicators that should prompt suspicion of FASD, particularly within justice-involved populations. The session will also highlight the health and economic consequences associated with FASD, emphasizing the importance for forensic psychiatrists to address this condition.

Participants will gain insights into the neuropsychological profiles of individuals with FASD, particularly those who are justice-involved, allowing for a more comprehensive understanding of their cognitive and behavioral challenges. The session will also focus on the skills required for assessing criminal responsibility and determining fitness to stand trial in individuals with FASD, ensuring that forensic assessments are both accurate and appropriate. Additionally, the

comorbidity of ADHD in individuals with FASD will be discussed, underlining its clinical and forensic significance. By the end of this session, attendees will be better equipped to identify, assess, and manage FASD, contributing to more effective forensic practice and improved outcomes for affected individuals.

### Bio – Mansfield Mela, MBBS, FWACP, M.Sc Psych, FRCPC

Dr. Mansfield Mela (MBBS, FWACP, MSc Psych, FRCPC), Professor, Department of Psychiatry, University of Saskatchewan, is an academic forensic psychiatrist and a Founder of the forensic subspecialty in Canada. He is also the current director of the Centre for Forensic Behavioural Science and Justice Studies at the University of Saskatchewan. He is also a member of the executive committee of the Canadian Medical Protective Association

As an expert, Dr. Mela testifies on various aspects of the interface of law and psychiatry, which include criminal and civil matters. He is an associate faculty member of the College of Law at the University of Saskatchewan and teaches undergraduate and graduate medical and law students. He is the co-lead of the patient-oriented research hub in forensic mental health in Saskatchewan, a member of the Saskatchewan Review Board and the Saskatchewan Physician Health program, and Vice Chair of the Forensic Research Network. Dr. Mela was a pioneer member and lead of the interdisciplinary research team of academic professionals in forensic mental health research at the University of Saskatchewan. His research focuses on psycho-legal aspects of forensic mental health, with specific interests and expertise in the area of Fetal Alcohol Spectrum Disorder (FASD). He is a lead researcher with the Canada FASD research network (CanFASD). His other research interests include the role of spirituality, religiosity and forgiveness in moderating criminogenic factors. He brings a clinical and patient-oriented perspective to his research questions and seeks to generate research and implement knowledge to achieve evidence-based practice amongst forensic mental health and FASD populations. Reducing victimization and improving patient outcomes especially among the vulnerable, form the foundation of his clinical and scholarly activities.
